# **ROADS:**

- 1. Request from Sheldon Larson to vacate a portion of Front Street in Hamlin Lake Resort which is a "paper street" running between Lots 3, 4 of Block 23 and the South 50' of the North 100' of Block 24 in the re-plat of Hamlin Lake Resort in Section 22.

- 2. Submitted a contract to the Mason County Road Commission to remove the existing corrugated metal bridge deck and hot mixed asphalt surface on the Middle Bayou Bridge. Repair steel beams as necessary, replace corrugated metal bridge deck, hot mixed asphalt surface and related work. Work could possibly be completed yet this year. Cost \$89,613.08.
- 3. Mason County Road Commission estimated various earthwork road projects for Hamlin Township to prepare the roads to be paved. Proposed to accept the Earthwork contacts on W. Victory Drive; Tamarac Street, Sassafras Street for 2024 which totals \$391,383.12. Plus Middle Bayou Bridge is a grand total of \$480,996.12. Review additional funding of \$81,000 for 2024 road work.

# FREEDOM OF INFORMATION ACT INQUIRES:

\*MCL 21.153 Obligations due state or municipality; "payment in check or bank draft, date operative, legal tender. Whenever a check or bank draft shall be tendered for the payment of any debt, taxes or other obligation due to the state or to any municipality therein, such check or draft shall operate as a payment made on the date the check or draft was received and accepted by the receiving officer, if it shall be paid on presentation without deduction for exchange or cost of collection. All agencies of the state of Michigan shall request that checks tendered in payment of an obligation due the state shall be made payable to the state of Michigan. No receiving officer shall be required to receive in payment of any debt, taxes or other obligation collectible or receivable by him any tender other than gold or silver coin of the United States, United States treasury notes, gold certificates, silver certificates or Federal Reserve bank notes."
